Creative Commons

There is a growing demand from funding agencies that research data should be reusable. There will be an ongoing debate on this issue, which SAR observes carefully.

Portal Partner Policies

Portal Partners decide themselves, in which data policy they use for their portal(s).

The EU General Data Protection Regulation (GDPR)

This regulation may have an effect on the RC procedures. SAR will check this further with relevant expertise.
