#### • Preliminary Accounts 2023

Overall, the income is somewhat lower than estimated in the GA endorsed working budget, but this is compensated by all-in-all lower expenditures, providing an expected estimated annual result close to zero. This should be seen in relation to the endorsed budget, which was agreed without a surplus.

It is estimated estimate that SAR at least will keep the non-committed reserve / working capital of approx. € 55.000 by the final accounts for 2023. First Draft Working Budget 2024 The preliminary accounts were taken into account.

# Amendment of Articles

The Ex.B endorsed in principle to propose the following two amendments to the GA:

### First Amendment:

SAR General Assemblies(GA) will take place every second year, to be implemented from 2024 onwards(which will mean that next GA will take place in 2026). In the year of no GA, the Ex.B will call a members' meeting to discuss current affairs and further developments.

### Second Amendment:

Voting rights for individual members will only be available for those members that has been registered as paid members continuously for more than one year by the end of the year before the GA takes place. Individual members that fulfil bullet point one and institutional members may participate and vote in online/hybrid GAs–conducted according to Swiss laws and regulations.

Draft for the final wording of the amendments will be presented in the March meeting.
